QUESTION ONE (COMPULSORY)

CASE STUDY: CHEATERS

NEC is Kenya Nation Examination Council is a body specialized in preparing National examinations. Unfortunately in one of examination centers by the name Nyakemincha. Being a private college, at least some of the paying students received a solid testing-day advantage: besides learning the typical tips and pointers, the college acquired stolen Nation Examination Council examination papers and used them in their training sessions. It's unclear how many of the question papers that students practiced on subsequently turned up on the main examination they took in November 2016, but some certainly did. The National Examination Council realizing this counseled the result of the college. As a result, the College Board, parents and students cried foul and took NEC to court.

The lawsuit fell into the category of copyright infringement, but the real meat of the claim was that Nyakemincha helped kids to cheat, the college was caught, and now it had to be punished by paying for those students whose result was counseled. The College Board's, parents and students case was very strong but after realizing that they were losing. Nyakemincha accepted the cold reality that it was going to get hammered, and therefore agreed to a settlement offer from the National examination council that included this provision: that the college would provide Kshs 4,000,000 worth of free NEC and tuition fees to college students who could not afford to pay the fee themselves to enable them to re-sit for the examination.
